### PROJECT KITCHENS LIMITED - WEBSITE TERMS OF USE / PRIVACY POLICY

These Terms and Conditions apply to your use of the Project Kitchens Limited ("Project Kitchens") website at www.projectkitchens.co.nz ("Website") and any other social media website or page, containing pages or content established by, or associated with Project Kitchens, including, but not limited to Facebook ("the Internet Sites").

#### 1. Terms

By using any one or more of the Internet Sites you are deemed to have read and agree to be bound by these Terms and Conditions. If you do not accept these Terms and Conditions, you must cease accessing the Internet Sites immediately.

### Amendments

Project Kitchens reserves the right to amend these Terms of Use from time to time. Amendments will be effective immediately upon being placed on the Website. Your continued use of the Internet Sites following such amendments being placed on the Website will represent an agreement by you to be bound by the Terms of Use as amended. Such amendments may include replacing these Terms of Use with entirely new Terms of Use.

### Content

While Project Kitchens endeavours to take all reasonable and appropriate care in the preparation of the content on the Internet Sites and has no reason to believe that any information contained on the Internet Sites is inaccurate, Project Kitchens does not warrant the accuracy, adequacy, or completeness of such information or that such information is error free. ## 4. Posting Policy

### Accessing
